

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the <https://pethomeeuthanasia.com/> and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Pet Home Euthanasia include <https://pethomeeuthanasia.com/>, PHE and <https://www.pethomeeuthanasia.com/>. The PHE website is an Mobile Pet Euthanasia Service Site.

By using the PHE website, you consent to the data practices described in this statement. Collection of your Personal Information PHE may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future. Information about your computer hardware and software may be automatically collected by PHE. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the PHE website.

PHE encourages you to review the privacy statements of websites you choose to link to from PHE so that you can understand how those websites collect, use and share your information. PHE is not responsible for the privacy statements or other content on websites outside of the PHE website. Use of your Personal Information PHE collects and uses your personal information to operate its website(s) and deliver the services you have requested. PHE may also use your personally identifiable information to inform you of other products or services available from PHE and its affiliates. PHE may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered. PHE does not sell, rent or lease its customer lists to third parties. PHE may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. PHE may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Use of Cookies The PHE website

may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize PHE pages, or register with PHE site or services, a cookie helps PHE to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
